1% increase in Proposed Pledges over 2019 Actual Pledges.

\$30,000.00 in restricted money. \$19,000.00 DIT money with an additional \$11,800.00 from Endowment to go into savings account this year.

Margie is going to meet with insurance agent to go over insurance quote. Hoping for decrease in liability with new stove, roof and furnace.

We may need to pay 100% of medical insurance for new rector where we are currently only paying 50%, as Stephanie's church picks up 50%.

Although more expensive, the Vestry felt that the HDV U material would be more cost effective in the long run and would hold up better over time.
